In 2003 the Anglican clergy of the Diocese of Niassa elected Revd Mark Van Koevering, a curate in Wales, as their Bishop.

Mark had spent most of his adult life in Mozambique, even during the civil war, as an agronomist and Aid worker meeting his wife Helen, also an Aid worker, there too. They married in Maputo in 1990 and have 3 children. Both speak fluent Portuguese, some local languages, and are ordained.

Since Mark's enthronement in Sept 2003 the Niassan church has experienced phenomenal growth almost doubling in size as well as being practical good news in one of the poorest regions of the world

Mark and Helen were funded through USPG until April 2011 but this has now ceased. New support is needed for the final period of 5 years to consolidate the growth and build up even more church leaders, lay and ordained, so the church is prepared for the multiplication of dioceses and local Bishops.

The new Van Koevering Trust Fund has been set up to support this ministry. It needs to raise £30,000 a year for 5 years to succeed: the equivalent of 100 people giving £25 a month for 5 years or 500 people giving £5 a month for 5 years.
